* REGISTRATION FEES AND CERTAIN DEPOSITS ARE NOT REFUNDABLE. Registration fees will be assessed every year in May or August (depending on your class or season). Registration fees are \$25 for the first child and \$15 for each additional child.

* It is your responsibility to make your tuitions payments on time. Tuition is due the first business day of the month and will be considered late after the 5th of each month. A \$20 late fee will be assessed if payment received after the 5th. If payment has not been received by the 15th of each month, your child will not be able to participate in class.

* There will be a \$25 service charge applied if a check is returned for insufficient funds.

* If you need to make-up a class, it is your responsibility to get with the owner or coach to determine and arrange the make-up class.

* Parents must pick their children up immediately following the end of the class. Cheer Company Allstars, LLC is not responsible for children not participating in a class.

If you are withdrawing from a class, you are required to give Cheer Company Allstars, LLC a 30 written notice. You are responsible for full payment for the month that you fail to give notice. This may be waived for emergent or serious circumstances but is at the discretion of the owner.

* I understand that participation in tumbling, dancing, and cheering involves motion, rotation, jumping, and lifting and as such involves the risk of injury. I understand as a spectator or parent participating in a parent-child class that there is also a risk of injury. I understand that I will be responsible for all medical expenses which may occur from my child's participation at Cheer Company Allstars, LLC, including my own or my family's.

* I understand that I must provide a copy of my child's current physical and authorization for sport participation within 90 days of registration.
